**AMENDMENT TO
CONSENT DECREE**

THE TOWN OF WALLKILL and THE TOWN
OF WALLKILL POLICE DEPARTMENT,

Pursuant to Paragraph 83 of the Consent Decree (the "Decree") signed by all parties to this action on February 21, 2001, and pursuant to this Court's Order, dated March 29, 2001, the parties, by their undersigned counsel, hereby amend the Decree as follows:

ONE: Paragraphs 55-57 of the Decree are hereby deleted.

TWO: The following new paragraphs 55-57 shall be substituted into the Decree, and, upon entry of the Decree, shall be binding upon the parties as though fully set forth therein:

55. The Court shall select an independent auditor (the "Auditor") to ensure oversight and compliance with this Decree.
56. Within 30 days of the date of this Decree, the Court shall submit to the parties the name of the proposed auditor to ensure that no conflict or similar consideration would disqualify the candidate from serving as Auditor. The parties shall have 10 days to notify the Court of any such conflict or other

consideration.


57. Within 20 days of the date of this order and (C)
Prior to the Court's naming of an auditor, the parties may – with notice to opposing counsel – propose to the Court either candidates for the Auditor position or qualifications which they believe will be necessary for any person to carry out the duties of the Auditor.


